

### **Consent for the Processing of Personal Data**

The personal data of the child and their parents or legal guardians will be processed by the Preschool Operator - Marlena Gulewicz, located at Niepubliczne Przedszkole Misie Filipisie, al. Jana Pawła II 192, 31-982 Kraków (Administrator) for the necessary purposes of running the Preschool, including:

Recruitment,  
Childcare,  
Prophylaxis,  
Educational activities,  
Communication with parents or legal guardians,  
Statistical purposes,  
Financial purposes,

In terms of the child's image, for documenting the activities of the Preschool and publishing on the website [www.filipisie.pl](http://www.filipisie.pl) and the INSO application.

The processing of children's personal data includes: name, surname, address of residence, registered address, place of birth, PESEL (Personal Identification Number), image (in the form of photos and videos), information on the results of initial and final pedagogical-psychological observations, diagnosis of school readiness, information on the results of screening phonological examinations, information on health status, information from notes from conversations with parents, information collected for conducting and supervising logopedic classes by students of the Pedagogical University in Krakow, information about family status, information about single parenting by one of the parents/guardians, information about the child's diet, information about attending religious classes, information about the future school facility based on zoning, information whether the child's siblings attended kindergarten in the school year 2023/2024, director's comments on the child included in the application for admission to kindergarten, information whether the child has been qualified and accepted to kindergarten and to which preschool group and from which date, the date on which the contract with the kindergarten will be terminated and for what reason, information that the child has not been qualified and has not been accepted to kindergarten, inclusion of the child on the waiting list and in which preschool group, information that the child is on the list of preschoolers in a given month of the school year, and personal data of parents or legal guardians including names and surnames, PESEL, address of residence, mobile contact phone numbers, stationary contact phone numbers, emails, places of work (cities), names of workplaces, or other gainful activities, information about whether there is single motherhood/fatherhood in the family, information about whether the parents have a significant or moderate disability certificate, a certificate of total incapacity for work or total incapacity for independent existence, information about whether the family performs the function of a foster family, information about the personal data of people authorized to pick up the child: name, surname, mobile contact phone number, PESEL.

Personal data regarding the child's health is necessary to ensure proper care tailored to the child's individual needs and medical recommendations.

Information about attending religious lessons is essential to enable the child to participate in such activities or to organize alternative classes.

The above-specified personal data, especially health-related data, will be subject to full protection and will be processed (including collection, storage, recording, and viewing) by the Administrator based on this consent (starting from May 25, 2018, also based on Article 6(1)(a) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016, on the protection of natural persons concerning the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC).
